#### CITY OF JACKSON UTILITY CHARGES

Effective May 1, 2021 and all subsequent revisions dates. Last revision 9-22-2021

#### FOR ANY ACCOUNT HOLDER DURING NORMAL BUSINESS HOURS

Fee for turning on or off water service: \$25.00

Fee for turning on or off electric service: \$25.00

Replacement of a water meter antenna, per visit: \$50.00

Replacement of water meter lid, per visit: \$25.00

- This is to turn off water or pull electric meter only, larger fee's will occur to pull commercial meters or cut the service line to an
  electric meter, during normal business hours.
- Fee will be added to the next billing cycle unless this is a delinquent turn off/on account.

# TO CUT ELECTRIC SERVICE AT THE POLE

\$100.00 during normal business hours (2) linemen for disconnect and re-connect, for after hours, see below.

# **SERVICE CALL RATE/FEE:**

Service call rates, for service by the City on a consumer's premises in connection with any defect or breakdown in the electric, water or sewer, beyond the tie-in with the main line, the charge for such service shall be as follows:

- Call out charge after hours to turn off water accounts shall be charged at a rate \$100.00 (one hundred dollars)
- Call out charge after hours for electric or to turn on a delinquent account shall be charged at a rate \$300.00 (three hundred dollars) plus delinquent and current charges along with turn on/off fees.
- The turn-on shall be performed only during normal business hours unless the above rate is paid.
- No utility services will be turned off for delinquency on a Friday or the day before a holiday.

#### **CUSTOMER REQUESTED METER CHECKS FOR ELECTRIC OR WATER:**

If the City checks an electric or water meter and meter is found to be accurate the fee shall be \$50.00. If meter is found to be faulty, no charge will be incurred & an adjustment will be made.

# FEE FOR INSPECTION NON-CITY INSTALLED UPGRADES OR NEW ELECTRIC SERVICE AND INSTALLATION OF WATER SERVICE:

- 1<sup>st</sup> trip no charge
- 2<sup>nd</sup> and any repeated trips shall be charged \$50.00 each trip made, during normal business hours if it falls outside of normal business hours, a service call fee will be assessed and added to the next billing cycle.

# **ELECTRIC TAP FEES:**

Any consumer who desires to tap into the City's electric service shall be charged tap fee as follows:

• Single Phase service: \$400.00

3 phase service: \$600.00

Additional construction costs may apply

### PRIVATE AREA LIGHTING:

For residential, commercial or industrial whether inside or outside the City the following monthly fees will apply:

The City will replace the fixture or bulbs for a fee which shall be equal to the actual cost of the fixture or bulb and labor during the regular schedule of working hours of the City. The customer shall promptly notify the City of outages.

New applicants, commercial or industrial only, (NO NEW RESIDENTIAL) for Private area lighting must make application to the Electric Department and upon approval the property owners shall be bound under the foregoing provisions for a term of not less than 5 years and the application shall set forth that the property owner agrees to be bound for such term. The application shall also include, but not be limited to, the following provisions:

- 1) The determination of the method of supply and type of facilities rests solely with the City.
- 2) The customer shall provide such cleared rights of way, licenses, permits and properly executed easements as may be required to enable the City to supply the service applied for.
- 3) In the event poles and/or wire is required to be installed to put up the lamps, then the customer shall pay to the City an amount equal to the actual cost of installing the poles and/or wire, which shall include, but not be limited to the pole, labor, supplies, etc. This cost shall be calculated by the City. All fees shall be paid in advance.
- 4) Upon early termination of the contract, a fee of one-half of the remaining contract balance shall be assessed to the property owner's final bill.
- 5) The City shall have the sole discretion in deciding whether to supply the service and service may be denied by the City for any reason, including but not limited to, if, in the judgment of the City, a danger or nuisance will be created thereby. If service has been supplied, then service will be terminated if there is a danger or nuisance, and the applicant will not be bound in the future.
- 6) Rates are based upon continuous use of the facilities and are not applicable to seasonal usage.

# Existing residential customers shall continue to be maintained but are subject to the following:

- If the service is disconnected or transferred, the City shall physically remove the private area lighting that is billed through
  the City and the service will no longer be provided. The only exception to this rule is to upgrade the existing service or storm
  damage.
- 2) In the event the light cannot be repaired without replacing the fixture, the light shall be removed and the service no longer provided.
- 3) After May 1, 2025 the City will begin removing existing area lights still in service.

If the contractor supplies all parts and labor in installing the service, the tap fee shall be \$500.00.

# ALL SEWER TAPS \$500.00

- The City of Jackson or a contractor registered with the City and qualified for such installs will install all taps.
  - No connection to a sanitary sewer or to a storm shall be made until a written permit is issued to the owner or the owner's representative upon application to the City.
- For any City installed taps that result in unusual circumstances that result in additional costs, those costs will result in additional charges, as determined by the Head of Department and Service Director.

If the contractor supplies all parts and labor in installing the service, the tap fee shall be \$250.00.

Rules 8

4) Contractors will expose the City's main on sewer line work, line

# **STREET BONDS:**

A street bond shall be calculated at the time the sanitary sewer tap or storm sewer tap is requested, and such bond shall be posted prior to any work being performed. The street bond shall be calculated for the repair of the pavement and/or damage due to lateral construction, minimum amount will be \$1000.00 (one thousand dollars).

# **MATTRESS BAG:**

COST PER BAG \$4.00

Large furniture items, including but not limited to sofas, chairs, or bedding will be assessed an additional charge of \$15.00 per item.

- All furniture and bedding items with cloth coverings must be sealed with plastic and tape. Fee will be added to the next billing cycle.
- Bagged garbage over six (6) bags will be charged to the utility account at a rate of \$1 per bag or as determined by the Garbage
  Department. Loose garbage will be charged by the cubic yard. The Department Head of Services will have the authority to
  determine a fee for excessive amounts of garbage. Fees will be added to the next billing cycle.

Additional dumps on a commercial or rental temporary dumpster will be charged at a rate of 25% of the total monthly rate.

Fees will be added to the next billing cycle.
