ORDINANCE NO. 118-07

AN ORDINANCE FINDING THE LOWEST RESPONSIBLE AND RESPONSIVE BID, AWARDING THE CONTRACT FOR PHASE II OF THE BIKE PATH PROJECT TO HALL FAMILY EXCAVATION CORP., 337 CLINTON IRON FURNACE ROAD, WHEELERSBURG, OHIO 45694, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

Council finds that Hall Family Excavation Corp., 337 Clinton Iron Section One. Furnace Road, Wheelersburg, Ohio 45694, is the lowest responsive and responsible bidder for Phase II of the Bike Path Project. This contract has been lawfully advertised and bid, and the lowest responsive and responsible bid is in the amount of One Hundred Sixty-Two Thousand Five Hundred and No/100 Dollars (\$162,500.00). This contract shall be paid from line item 406-7320-53064.

The Mayor or the Service Director is hereby authorized to execute this Section Two. Contract and any financing documents according to the terms of the lowest responsive and responsible bid.

Section Three. This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health, or safety of the City of Jackson, in that it is necessary to accept this bid as soon as possible to receive the bid price, and in order to commence with this project as soon as possible. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

In the event this Ordinance receives a majority vote for passage but fails Section Four. to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

Section Five. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council that resulted in those formal actions were in meetings open to the public, all in compliance with the law. ealmen
