ORDINANCE NO. 42-09

AN ORDINANCE CREATING THE PART TIME POSITION OF ASSISTANT POOL COORDINATOR, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO. as follows:

Section One. The position of Assistant Pool Coordinator is hereby created. The Assistant Pool Coordinator will be a part time, seasonal position. The Assistant Pool Coordinator shall be responsible opening the municipal swimming pool each day, tersting and assuring the chemical levels of the municipal swimming pool are in compliance, and such other duties as directed by the Mayor. The position of Assistant Pool Coordinator shall be compensated at Three Thousand Dollars (\$3,000.00) per year, and the position shall not be entitled to any benefits other than those required by law.

<u>Section Two.</u> This Ordinance is hereby declared to be an emergency Ordinance, necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, in that it is necessary to amend this Codified Ordinance Section as soon as possible in order that the new rates may take effect upon the opening of the Municipal Swimming Pool for the 2009 season. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

<u>Section Three.</u> In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

<u>Section Four.</u> In is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
