ORDINANCE NO. 104-10

AN ORDINANCE FINDING THE LOWEST RESPONSIBLE AND RESPONSIVE BID, AWARDING THE CONTRACT FOR THE 13.2 kV 4/0 ACSR CIRCUIT 4 CONVERSION PROJECT TO NEW RIVER ELECTRICAL CORP., 15 CLOVERDALE PLACE, CLOVERDALE, VIRGINIA 24077, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

Section One. Council finds that New River Electrical Corp., 15 Cloverdale Place, Cloverdale, Virginia 24077, is the lowest responsive and responsible bidder for the contract for the 13.2 kV 4/0 ACSR Circuit 4 Conversion Project. This contract has been lawfully advertised and bid, and the lowest responsive and responsible bid is in the amount of Four Hundred Ten Thousand Three Hundred Twenty-seven and 97/100 Dollars (\$410,327.97). This contract shall be paid from line item 731-7555-54005 – Electric Fund: Utility Distribution Systems.

<u>Section Two.</u> The Mayor or the Service Director is hereby authorized to execute this Contract and any financing documents according to the terms of the lowest responsive and responsible bid.

<u>Section Three.</u> This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health, or safety of the City of Jackson, in that it is necessary to accept this bid as soon as possible to receive the bid price, and in order to commence with this project as soon as possible to meet pending timelines. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

<u>Section Four.</u> In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

Section Five. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council that resulted in those formal actions were in meetings open to the public, all in compliance with the law.

- 2. BID PRICE: All pricing shall be stated in both words and figures. In case of discrepancy between words and the figures, words shall govern.
- 2.1 BASE BID: The base bid shall include and provide all equipment, materials, labor, freight, etc. necessary to complete the 13.2 KV 4/0 ACSR CIRCUIT #4 CONVERSION. The base bid is to be broken down into three sections; 1) Section 1 is Removal Assembly Units; 2) Section 2 is New Assembly Units and 3) Section 3 is Transfer Assembly Units.

The assembly units that are included in Section 1, 2 and 3 are defined by symbols and descriptions on Construction Drawings, which follow together with the applicable descriptions included in this section. Where the descriptions are not correct or sufficiently explicit, or when special units are not covered by Construction Drawings, descriptions have been provided by the Owner in the respective sections.

NOTE: Replacement Units, if present on Construction Drawings, consist of both a removal and new assembly units in the count of units that follow.

NOTE: The following Detailed Breakdowns of Section 1, 2 and 3 base bids included in the following tables are NOT a "project takeoff". It is the responsibility of the Contractor to review the project details and determine the exact quantities of units and miscellaneous hardware necessary to complete the scope of work defined herein.
