ORDINANCE NO. 47-12

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO AUTHORIZE THE SERVICE DIRECTOR TO PURCHASE THE EXISTING TRANSFORMER FACILITY AND RISER POLE AT THE JACKSON WATER PLANT AT A COST NOT TO EXCEED \$25,595 AND FINDING THAT EMERGENCY CONDITIONS EXIST SO AS TO OBVIATE ANY FORMAL BIDDING AND ADVERTISING REQUIREMENTS FOR CONTRACTS AND DECLARING AN EMERGENCY.

WHEREAS, AEP is the owner of an installed transformer and riser pole which may be used in conjunction with the City's line build at the water plant; and

WHEREAS, it has been determined that a transformer and riser pole is necessary for the completion of the line build project and that the AEP transformer and riser pole is already installed at the plant and, as installed, is only available from AEP; and

WHEREAS, this matter constitutes a real and present emergency for the reason that timely completion of the water plant line build is necessary for the preservation of the health, safety and welfare of the City of Jackson and its residents and that, under the authority of R.C. 735.051, the conditions obviate requirements for formal bidding and advertising for contracts.

WHEREAS, funds have been appropriated for the water plant line build and that these funds should be paid from line item 732-7560-54002.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

Section 1. The legislative authority of the City of Jackson hereby authorizes the Director of Service and Public Safety of the City of Jackson, Ohio to enter into a contract with AEP for the purchase of the transformer facility and riser pole at the Jackson Water Plant at a price not to exceed \$25,595 and shall be paid from line item 732-7560-54002.


Section 2. This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio and that, under the authority of R.C. 735.051, the conditions obviate requirements for formal bidding and advertising for contracts.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
