The following is a/an Ordinance enacted by the City of Jackson of Jackson County, Ohio,  
(Ordinance/Resolution) (Local Public Agency)  
hereinafter referred to as the Local Public Agency (LPA).

### SECTION I – Project Description

WHEREAS, the (LPA/STATE) has determined the need for the described project:

*It is proposed to replace the Huron Street Bridge and the Dickason Street Bridge. Part of Ohio Brdg Partnership.*

NOW THEREFORE, be it ordained by the City of Jackson of Jackson County, Ohio.

### SECTION II – Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

### SECTION III – Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

*The LPA shall be responsible for all financial resources necessary for those items outside the scope of the project, as stated above.*

#### SECTION IV – Utilities and Right-of-Way Statement

The LPA agrees that all right-of-way required for the described project will be acquired and/or made available in accordance with current State and Federal regulations. The LPA also understands that right-of-way costs include eligible utility costs.

The LPA agrees that all utility accommodation, relocation and reimbursement will comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

#### SECTION V – Maintenance

Upon completion of the Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the Project in accordance with all applicable State and Federal law, including, but not limited to, Title 23, U.S.C., Section 116; (2) provide ample financial provisions, as necessary, for the maintenance of the Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

#### SECTION VI Authority to Sign

I, Mayor of said City of Jackson is hereby empowered on behalf of the  
 (Contractual Agent) (LPA)  
City of Jackson to enter into contracts with the Director of Transportation which is necessary to  
 (LPA)  
 complete the above described project.
