ORDINANCE NO. 79-15

AN ORDINANCE REPEALING AND REVISING ORDINANCE 45-99 SO AS TO INCREASE THE COMPENSATION PAID TO THE CITY MAYOR EFFECTIVE JANUARY 1, 2016 AND DECLARING AN EMERGENCY.

WHEREAS, this legislative authority finds it beneficial to the City to repeal and amend Ord. 45-99 increasing the annual compensation paid to the City Mayor beginning January 1, 2016; and

WHEREAS, the City Mayor shall continue to be paid the same amount of annual compensation as being paid as of the date this Ordinance is adopted and the City Mayor and shall also be entitled to receive health insurance at the same rate as other City supervisors and all benefits provided by State law or City's policies until January 1, 2016; and

WHEREAS, effective January 1, 2016, and thereafter, the City Mayor shall receive an annual salary of \$50,000.00 together with health insurance at the same rate offered to other City supervisors and all benefits provided by State law and without other increase or decrease unless ordained by this legislative authority; and

WHEREAS, this matter constitutes an emergency and its passage is necessary to preserve the public health, safety and welfare as it will increase the salary to an amount suitable for the responsibility of the office.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON, OHIO THAT THIS MATTER CONSTITUTES AN EMERGENCY AND THAT ORDINANCE 45-99 IS HEREBY REPEALED AND AMENDED AND THE ANNUAL COMPENSATION AND BENEFITS PAID TO THE CITY MAYOR SHALL BE AS FOLLOWS:

- A. The City Mayor shall continue to be paid the same amount of annual compensation as being paid as of the date this Ordinance is adopted and the City Mayor shall also be entitled to receive health insurance at the same rate as other City supervisors and all benefits provided by State law or City's policies until January 1, 2016.
- B. Effective January 1, 2016, and thereafter, the City Mayor shall receive an annual salary of \$50,000.00 together with health insurance at the same rate offered to other City supervisors and all benefits provided by State law and without other increase or decrease unless ordained by this legislative authority.

This Ordinance is hereby declared to be an emergency Ordinance and its passage is necessary to preserve the public health, safety and welfare as it necessary to increase the salary to an amount suitable for the responsibility of the office. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.
