ORDINANCE NO. 55-20

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO AUTHORIZE THE PUBLIC SERVICE DIRECTOR TO ACCEPT THE PROPOSAL OF POWER SYSTEM ENGINEERING, INC. TO PROVIDE ENGINEERING SERVICES RELATED TO THE CIRCUIT SWITCHER UPGRADES AT THE LICK SUBSTATION AT A COST NOT TO EXCEED \$120,000.00 AND DECLARING AN EMERGENCY.

WHEREAS, the City of Jackson requires personal engineering services of a specialized nature requiring the exercise of peculiar skill and aptitude for design and electrical construction drawings, equipment and construction specifications for the installation of three new circuit switchers and associated microprocessor relays at the Lick Substation; and

WHEREAS, Power System Engineering, Inc. has provided similar personal services of a specialized nature to the City of Jackson and have been found to possess the peculiar skill and aptitude to perform the required services related to the Lick Substation project; and

WHEREAS, Power System Engineering, Inc. has submitted a proposal, attached hereto, to provide said services to the City of Jackson at a cost not to exceed \$120,000.00; and

WHEREAS, this matter constitutes an emergency so as to permit the design process to be completed so that construction may commence no later than Spring 2021 as a recent inspection has indicated the need for replacement switches and the replacement is necessary to protect the health, safety and welfare of the City and that, under the authority of R.C. 735.051, the conditions further obviate requirements for formal bidding and advertising for contracts.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

Section 1. The legislative authority of the City of Jackson hereby authorizes the Director of Service and Public Safety of the City of Jackson, Ohio to enter into a contract with Power System Engineering, Inc. for the required work for an amount not to exceed \$120,000.00 and shall be paid from line item 731-7555-53007

<u>Section 2.</u> This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio for the reasons set forth above.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
