ORDINANCE NO. 34-22

AN ORDINANCE FOR REIMBURSEMENT OF PRIOR ADVANCEMENTS FROM THE SEWER FUND AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

Section 1: The following is an advance reimbursement as follows:

ADVANCE FROM

449-7610-56001 Lift Station Upgrade Fund: Advance Out \$155,890.47 450-7610-56001 Parkview to Main Sanitary Sewer: Advance Out \$809,507.00

ADVANCE TO

711-0900-40915 Sewer Fund: Advance In

Section 2. This is to make reimbursements to the Sewer Fund for prior advances made to Funds 449 and 450. The total amount reimbursed is \$74,950.56 less than the original advancements as that amount represents the City's required match to the Lift Station Upgrade project. This is an emergency necessary to maintain the public health, safety and welfare so that the City's financial records are correct. Therefore, this Ordinance shall go into effect upon passage and as provided in Ohio Revised Code Section 731.30.

<u>Section 3.</u> In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
